- Healthcare Professionals and mid-to-senior level officials involved in the Healthcare policies and community Health Services.
- Proficient in written and spoken English; and in good health.

Objectives

- The course aims to provide participants with an understanding of Primary Healthcare Systems, with emphasis on women, children and the elderly, through Singapore's own experience and best practices in community healthcare management and system.


