- i. CFO shall have no conflict of interest and shall issue a declaration of no conflict.
- ii. Preference to Age 45 yrs and above.
- iii. Govt/Semi Govt Servants to apply through proper channel and would be required to produce NOC at the time of interview.
- iv. NIH employees eligible for promotion with minimum service 12 years and fulfilling eligibility criteria of the post also to apply.
- v. Eligibility of candidate will be determined on the basis of higher academic qualification, experience etc. as given against the post.
