

DRAFT POLICY ON BEHALF OF SECRETARY, M/O NHSR&C FOR IMPLEMENTATION OF JUDGEMENT OF HONORABLE SUPREME COURT OF PAKISTAN

1. Consequent to directions of Lahore High Court, Lahore in W.P. No.43757 of 2022 in Orders dated 08-02-2023 with regard to submission of draft policy on affairs of Shaikh Zayed Post Graduate Medical Institute (SZPGMI), Lahore, a committee was constituted with the approval of Secretary, M/o NHR&C (**Annex-I**), which held its meeting on 20-02-2023 under the chairmanship of Special Secretary, M/o NHR&C in his office. Minutes of the said meeting are attached at **Annex-II**.
2. The Shaikh Zayed Post Graduate Medical Institute (SZPGMI), Lahore with the approval of its previous Board has filed CMA before the Supreme Court to seek clarification on interpretation of its judgement dated 17-01-2019. However, on re-examination of the Judgement of Honorable Supreme Court dated 17-01-2019, it is concluded that appointments/promotions/upgradations were apparently made in SZPGMI following due process during Punjab Government's tenure and these are not inconsistent with or in derogation of the tenor of the Order of the Supreme Court.
3. Thus, in order to carry out the pending promotions of SZPGMI, the lists of employees along with other details were asked from SZPGMI vide this Ministry's letter dated 02-03-2023. SZPGMI has provided the lists, which are attached at **Annex-III**. As per lists provided, there are about 81 promotion/placement cases for different grades of Shaikh Zayed Hospital (SZH) and Shaikh Fatima Institute of Nursing & Health Sciences (SFIN&HS) against around 98 vacant posts reserved for promotion/placement. Moreover, there are about 75 cases of promotions of Federal Postgraduate Medical Institute (FPGMI) component against around 72 vacant seats.
4. As about promotions to different grades, the promotion criteria to be met are the first requisite for consideration of these cases for promotion by respective DPCs. These criteria are stated broadly as below:






