
Observations of FPSC	Views of Establishment Division
(i) In (Rule-3) under column-3 (Medical Cadre) the qualification i.e MBBS/BDS have been proposed for promotion to the post of Deputy Director (BS-18) while the qualification i.e BDS has not been proposed for promotion to the post of Director (BS-19).	(i) For promotion to the post of Director (BS-19) academic qualification of BDS deemed to have been incorporated in Rule -3 of earlier approved draft Recruitment Rules.
(ii) In schedule against (Medical Cadre) the qualification MBBS/BDS have been proposed against the posts of Director (BS-19), Deputy Director (BS-18) and Assistant Director (BS-17) but the qualification i.e BDS has not been proposed against the post of Director General (BS-20).	(ii) For initial appointment to the post of Director General (BPS-20) academic qualification of BDS deemed to have been incorporated in schedule of earlier approved draft Recruitment Rules.
(iii) In schedule under (column-3) qualification i.e MBA/MPA/ M.A/MSc have been proposed against the posts of Director (BS-19), Deputy Director (BS-18) and Assistant Director (BS-17) while the said qualification have not been mentioned against the post of Director General (BS-20).	(iii) Fr initial appointment to the post of Director General (BS-20) academic qualification of MBA/MPA/MA /MSc deemed to have been incorporated in schedule of earlier approved draft Recruitment Rules.
